The Federal Reserve's latest [109th Annual Report of the Board of Governors of the Federal Reserve System \(2022\)](#) to Congress hides its ownership from the public.

### **Annual Report hides owners**

The bloated 224-pg. report makes reference to “capital stock,” “beneficial ownership,” and “dividends,” but never identifies the names of the holders and beneficiaries. Such a disclosure is required of reports to the Securities and Exchange Commission and is a glaring omission.

An oft-cited and snarky [Institutional Investor](#) article provides this information with the title: “Conspiracy Theorists Ask ‘Who Owns the New York Fed?’ Here’s the Answer” (Feb. 24, 2020). Evidently, the title implies that only conspiracy theorists would ask for *normally disclosed financial ownership information* (it’s called “beneficial ownership”). The author implies that the rest of the public just sits quietly with hands folded, waiting for the vaunted financial wizards to cast their spells.

As it turns out, that is exactly what the demonic Babylonian Rādhānite merchant-bankers did four millennia ago, and continue to do: cast their demonic spells.

The article says it took a FOIA request in 2018 to force the Fed to provide this information. Tellingly, a Fed spokesperson said, “[the Federal Reserve] as a matter of policy has previously not disclosed the capital share holdings of its 70-plus member banks.”

1. **Vanguard**
2. BlackRock (**Vanguard** controlled)
3. State Street (**Vanguard**, BlackRock controlled)
4. MUFG Tokyo (BlackRock, **Vanguard** control)
5. JPMorgan,\* Berkshire Hathaway,\*\* Goldman Sachs,\*\*\* PRC

\*JPMorgan (**Vanguard**, BlackRock control)

\*\* Hathaway (**Vanguard**, BlackRock, State Street control)

\*\*\*Goldman Sachs (BlackRock, State Street, **Vanguard** control)
